


# Welcome to CyberNorth's August Newsletter

### Flexi-Job Apprenticeships

A new approach is needed to help businesses access upcoming talent and for the next generation to gain the experience they need in today's modern world of work.

#### The Challenge:

- The cyber industry faces a skills shortage
- A recognised need to work more collaboratively
- Barriers to recruitment including head count, HR processes
- A requirement to change the way in which education is delivered in Cyber
- Experience gap rather than skills gap

#### The Solution:

- Intensive cyber technologist higher apprenticeship programme
- Designed in collaboration with employers and delivered over two years on an annual cycle.
- Emphasis on designing, building and testing secure networks or security products or systems with a particular focus on the security aspects of the design.
- Proposed start date of September 2024

Gateshead College, in partnership with CyberNorth, are now uniquely placed to offer a new Flexi-Job Apprenticeship scheme centred around cyber security technology roles. We want to hear from any North East SME business and

organisation which already had a dedicated ICT department and is looking to secure future technology skills and growth needs.

#### Work Experience:

- PlanBEE is a shared apprenticeship scheme, with employment hosted by the North East Apprenticeship Company (NEAC)
- Designed to replicate real employment conditions and promote collaboration and multi-disciplinary team working
- Apprentices 'rotate' between sponsor companies to gain skills and experience
- For example, based on 8 employers and 8 apprentices; apprentices undertake 4 work placements (2 a year), for up to six months at a time this would mean not every employer would see every apprentice however this gives a longer period in a placement.
- Apprentices undertake real work and are treated as full time employees
- Move to a different employer after each placement to gain broad and varied experience working in different organisations
- Sign NDAs at each placement


The scheme's aim is for the apprentice to combine technology and cyber security studies with real-world experience with placements across several companies, in a cyber-related role, over the duration of the apprenticeship. This offers the apprentice a chance to experience different work-place environments and duties, as well as potential job offers at the end.

#### Benefits:

- Proven cost effective and innovative way to recruit and develop talented young people.
- 94% of our current graduates (on built environment) go on to secure roles with sponsor companies
- Intensive higher level apprenticeship programme designed by employers to ensure it meets real needs
- Broad content designed to ensure greater understanding and appreciation of multidisciplinary roles and collaborative working

The advantage of this flexi-job apprenticeship to smaller SMEs is that it allows flexibility in the number of apprentices a business has the opportunity to see at first-hand, bringing a broader range of talent into the sector.

## **Aspiring Cyber Leaders**

Congratulations to our latest Aspiring Cyber Leaders cohort.

Forts and castles have long been the place to protect secrets and fight battles, much as we do in cyber security. So it seemed fitting that we would host the final, fully-funded CyberNorth's aspiring cyber leaders programme at Lumley Castle, Chester-le-Street.

The cohort, consisting of nine aspiring leaders from regional cyber businesses, as well as private and public sector cyber teams, took part in the four day-long training

session held over a month, as well as mentoring and executive coaching.

This, the third fully-funded cohort from DSIT's CyberLocal funding, has now enabled almost 30 regional cyber leaders to hone their non-technical skills and develop their careers, build strong networks and advance their skills.

Each year, the conference hosts two days of discussions between cybersecurity experts of major companies (Hitachi, Cisco, Fincantieri, Ansaldo & more), national authorities such as the National Agency for Cybersecurity, the Ministry of Defence, as well as police forces, local authorities, professors and many more.

This event is much more niche than Cybertech. However, it allows for more direct contact with cyber security contacts in organisations and potential buyers.
